 - Large Scale Industry Member (LSI): Annual sales turnover above ₹100 crores
- Institutional Member (INST): Academic Institutions or Colleges, including ITI / Polytechnic colleges, or Research organizations.

- Completed document must be sent to the FPSI Secretariat, together with the Photocopies of Certificates.
